7-Act Format Worksheet UNWANTED ATTENTIONS

[aired as Shadow of Obsession]

Act I Scene

- Benjamin becomes mesmerized with Rebecca at library.
- 2. Benjamin follows Rebecca to her dorm.
- Benjamin befriends Wendy from Rebecca's dorm, to be close to her.
- Benjamin hears about campus party, harshly breaks off relationship with Wendy.
- At party Benjamin arranges to give Rebecca a ride home.
- Benjamin passes the turn for the campus. Rebecca begins to panic.
- 7. They struggle, he strikes her, threatens her with a knife ordering her to partially disrobe. He forces her to say she loves him, then returns a shaken Rebecca to dorm.
- Rebecca files charges, appears in court. Charges are dismissed as she is humiliated by judge.
- Benjamin follows Rebecca in his car, watches her through her window. Scratches heart on her car.
- Rebecca reads and destroys letters from Benjamin.
- 11. Rebecca keeps moving. He finds her each time, calling her. Rebecca is frantic with fear.
- 12. Suddenly Benjamin stops calling. Is he gone?

Act II

- Rebecca is now in love with Philip. He tells her about threatening telegram. It's from Benjamin.
- 14. She tells Philip about Benjamin. He's shocked.
- 15. Rebecca shows Philip articles about women who were stalked. They're all dead.
- 16. Rebeccà seeks help from her attorney friend Angela. She suggest a Pl, Michael Caruso.
- 17. Michael is immediately attracted to Rebecca. She confesses she wishe Benjamin dead.
- 18. Michael finds Benjamin's apartment. Michael discovers from dripping in blood.

Act II

- 19. Michael calls police. They go to see Rebecca. She's openly relieved that Benjamin is dead.
- 20. Police search her apartment and car. They find blood in the trunk.
- 21. DA begins investigation.
- 22. Evidence against Rebecca mount
- 23. She hires criminal lawyer Trevor Keegan. He questions her innocence
- 24. Blood in car matches Benjamin's Rebecca is indicted for murder.

HOUR STATION BREAK

Act IV

- 25. Benjamin's mother takes the stand and accuses Rebecca of being obsessed with her son.
- 26. Keegan refuses to cross-examine. Rebecca is angry.
- 27. A guilty Caruso attends trial.
- 28. Angela takes stand. Testimony backfires, seems to offer motive.
- 29. New DNA evidence is introduced by DA. Philip becomes convinced of Rebecca's guilt.
- 30. Philip refuses to testify and breaks engagement. Rebecca collapses.

Act V

- 31. Keegan serves Philip with a subpoena. Keegan is ruthless when Philip takes stand.
- 32. Caruso continues to investigate on his own.
- 33. Trial ends. Jury retires. Rebecca returns home to wait for verdict.
- 34. Rebecca is attacked in her bathroom, drugged and kidnapped.
- 35. Rebecca awakens in van. Benjamin is driving.
- 36. Benjamin allows Rebecca to go to a ladies' room. She discovers in old paper she's been convicted of murder.

Act VI

37. Benjamin imprisons Rebecca in cabin in the woods. Rebecca thinks about a way to escape. Benjamin barricades her in her room.

- 38. Rebecca makes breakfast. Attacks Benjamin with frying pan, then injects him with syringe.
- 39. Rebecca frantically searches for keys to van. Can't find them. Rebecca escapes on foot through woods.
- 40. Rebecca makes it to roadside hotel, calls Keegan. Call overheard by Caruso. He shows up at hotel.
- 41. Caruso reveals how Benjamin faked his own murder and that Keegan is going to set her up.
- 42. Caruso insists they return to cabin. When they get there, Benjamin is gone.

Act VII

- Rebecca begs to leave. Caruso notices Benjamin hiding, mentions hotel.
- 44. Rebecca gives in to Caruso's persuasion. Sheriff's dept. calls. Caruso leaves to meet the sheriff.
- 45. Caruso realizes mistake. As he returns to hotel room, he's knocked out.
- 46. Benjamin lets himself into room, then takes Rebecca to cliffs to throw both of them over.
- 47. Before Benjamin can go over edge, Caruso shoots him. Benjamin falls off cliff.
- 48. Rebecca stands before judge while he vacates judgment, dismisses case. Caruso waits for Rebecca outside the courthouse.
